

District of Innovation Plan

The 84th Texas Legislature passed House Bill 1842 in the spring of 2015, providing public school districts the opportunity to become Districts of Innovation. To qualify, an eligible school district must adopt a five-year innovation plan according to the Texas Education Code.

Sudan ISD is utilizing HB 1842, of the 84th Legislative Session, in order to have more local control in certain areas. HB 1842 allows a traditional public school to have some of the same local flexibility that public charter schools have always been allowed. We feel this is a great opportunity for our local district to again tailor a plan based on the needs of our students and community. Sudan ISD intends to follow the Texas Education Code in all other areas. Sudan ISD's Local Innovation Plan is comprehensive and touches numerous areas in the TEC, and because Sudan ISD seeks to maximize local control of educational decisions for students, Sudan ISD seeks exemption from the permissible provisions of the TEC included and explained in this Local Innovation Plan. Sudan ISD's Local Innovation Plan will begin with the 2023-2024 school year and will conclude at the end of the 2027-2028 school year, unless the plan is terminated or amended by the Sudan ISD Board of Trustees in accordance with HB1842. Any future amendments will adhere to the same term of the original plan.

Districts of Innovation may be exempt from state statutes to:

- Take greater local control as the decision makers over the educational and instructional model for students;
- Increase freedom and flexibility, with accountability, relative to state mandates that govern educational programming; and
- Increase empowerment and encourage innovative thinking.

House Bill 1842, passed in the 84th Texas Legislative Session, provides Texas public school districts the opportunity to amend certain state requirements at the local level to better meet the needs of their unique student populations.

INNOVATIONS

Sudan ISD, in conjunction with the District of Innovation Committee, proposes the following flexibilities with the Texas Education Code to provide the best educational opportunities for students at Sudan ISD.

1.) School Start Date

(EB Legal) (Texas Education Code 25.0811)

Currently

A District may not begin instruction for students for a school year before the fourth Monday in August unless the district operates a year-round system. A District may not receive a waiver for the requirement.

Sudan ISD Proposed

The flexibility of a locally approved start date allows the district to determine, on an annual basis, what best meets the needs of the students and local community. The flexibility of this start date also offers the following opportunities:

- Balancing the number of semester days while still finishing the first semester before the holiday break in December.
- An early start date permits students an additional week of instruction prior to state assessments.
- Students participating in Dual Enrollment opportunities will work with balanced semesters, which align with our local colleges.
- This would allow an option to start semesters with a shorter week, easing the transition for students entering elementary, middle school, and high school.
- Creates flexibility for the district to pursue other calendar options best suited for our identified populations.

Sudan ISD Guidelines

The district will determine, on an annual basis, when each school year will begin.

2.) Inter-District Transfers

(FDA LOCAL) (Texas Education Code 25.036)

Currently

Currently, under Texas Education Code 25.036, a district may choose to accept, as transfers, students who are not entitled to enroll in the district, but TEC 25.036 has been interpreted to require a transfer to be for a period of one school year.

Sudan ISD Proposed

Sudan ISD maintains a transfer policy under FDA (Local) requiring nonresident students wishing to transfer to file a transfer application each school year. In approving transfer requests, the availability of space and instructional staff, availability of programs and services, the student's disciplinary history records, work habits, and attendance records are also evaluated. Transfer students are expected to follow the attendance requirements, rules, and regulations of the district. TEC 25.036 has been interpreted to establish the acceptance of a transfer as a one-year commitment by the district. The district is seeking to eliminate the provision of a one-year commitment in accepting transfer applicants. On rare occasions, student behavior warrants suspension (in or out of school), placement in a disciplinary alternative program, or expulsion. In addition, student attendance may fall below the TEA truancy standard. In these rare cases, and following reasonable corrective measures, Sudan ISD seeks exemption from the one-year transfer commitment.

Sudan ISD Guidelines

Nonresident students who have been accepted as inter-district transfer students, may have such transfer status revoked by the superintendent, at any time during the year, if the student is assigned discipline consequences of suspension (in or out of school), placement in a disciplinary alternative program, or expulsion. In addition, students not meeting the State's 90% attendance standard may also be subject to immediate revocation of the transfer status.

3.) Teacher Certification

(DK LEGAL, LOCAL) (Texas Education Code 21.003)

Currently

In the event a district cannot locate a certified teacher for a position, or a teacher is teaching a subject outside of their certification, the district must submit a request to the Texas Education Agency. TEA then approves or denies this request. In certain circumstances, a district can use a local one-year permit.

Sudan ISD Proposed

In order to best serve Sudan ISD students, decisions on certification will be handled locally. Based on local need, this exemption from teacher certification requirements will enable greater flexibility in staffing and will enrich applicant pools in specific areas of need. The district's exemption from TEC 21.003 would allow the district to consider part-time professionals to teach courses, allow industry expert professionals to transition into the teaching profession in Career and Technology, and also assist in staffing high need STEM and dual credit course offerings. Out-of-state certified teachers could be considered for positions upon a local review of experience, education, and credentials. Often there are experienced certified teachers in our district that could teach a course outside of their certification area due to their education, background, and/or experience. Local decisions outside of state certification requirements would allow innovation and flexibility in scheduling to meet student needs. However, by law all special education and bilingual teachers will continue to meet SBEC certification requirements.

Sudan ISD Guidelines

The campus principal may submit to the superintendent a request to allow a certified teacher to teach a subject and/or grade level out of their field. The principal must specify the reason for the request and document what credentials the certified teacher possesses qualifying this individual to teach the subject. An individual with experience in a Career and Technology field may be eligible to teach a vocational skill or course. An individual may hold a teaching certification in another state for Core areas or Career and Technology. An individual may have background, experience, skills, or work related/industry experience to work full time or part time in a designated area. The principal will submit a request to the superintendent for local certification. The principal must specify the reason for the request and document what credentials the individual possesses qualifying this individual to teach the subject. The superintendent will approve or deny requests for local certification.

4.) Class Size Requirement

(EEB Legal) (Texas Education Code 25.111, 25.112, 25.113)

Currently

TEC §25.112 requires districts to maintain a class size of 22 students or less for Kindergarten – 4th Grade classes. TEC §25.113 requires districts to notify parents of waivers or exceptions to class size limits. TEC §25.111 requires districts to maintain a 22:1 student to teacher ratio for Kindergarten – 4th Grade classes.

Sudan ISD Proposed

Sudan ISD recognizes that smaller class sizes are beneficial and will continue to use the 22:1 student/teacher class size and ratio for Kindergarten-4th grade in projecting the number of staff needed for future school years. We also recognize that this fact must be balanced with the logistics of the timing of adding staff and continuing to employ the best qualified teachers. Many times, it is not the number of the students, but the makeup and chemistry of the classroom which influence the learning environment. Most importantly, research clearly shows it is the teacher in the classroom that has the greatest impact on student learning, not absolute class size. Sudan ISD would like local control in allowing a principal to get permission from the superintendent and School Board if a classroom has one or two students over the class size and ratio of 22:1. In order to best serve Sudan ISD students, we maintain the vision of being able to have the timing and latitude to hire the "right teacher" for kids and not rush to hire "any teacher" just to fulfill a mandate if we feel it necessary to hire a new teacher. Furthermore, the district proposes to notify parents if the ratio is higher than 24:1.

Sudan ISD Guidelines

The campus principal may submit a request to the superintendent and school board requesting permission to go over the 22:1 ratio in grades Kindergarten-4th while taking the time to do what is best to serve Sudan ISD students by either hiring an additional teacher, or by shifting class numbers to only exceed the 22:1 ratio by 1 or 2 students.

5.) Campus Behavior Coordinator

(FO Local) (Texas Education Code 37.0012)

Currently

TEC§37.0012 requires a person be designated to serve as the Campus Behavior Coordinator (CBC) who is primarily responsible for maintaining student discipline and implementation of Chapter 37 and allows duties imposed on a campus principal or other campus administrator to be performed by the campus behavior coordinator.

Sudan ISD Proposed

Sudan ISD has always taken a collaborative approach to student discipline on the campuses. With exemption from the requirement and duties of the Campus Behavior Coordinator, principals will be able to create the system where the duties of the CBC are shared among the administrative staff. This allows a more personal and effective approach to student discipline and better communication with parents. Campus principals already serve in this capacity, and a requirement to designate someone for this position is not necessary.

Sudan ISD Guidelines

Campus principals will continue to serve in this position, utilizing necessary administrative staff, to best serve Sudan ISD students.

6.) Probationary Contracts

(DCA Legal) (Texas Education Code 21.102)

Currently

TEC 21.102 states that a probationary contract may not exceed one year for a person who has been employed as a teacher in public education for at least five of the eight years proceeding employment with the district.

Sudan ISD Proposed

This one-year period of time may not be sufficient to evaluate the teacher's effectiveness in the classroom since teacher contract timelines demand the employment decisions must be made prior to the availability of end-of-year classroom and student data. Relief from TEC 21.102 will permit Sudan ISD the option to issue a probationary contract for a period of up to two years for experienced teachers and counselors newly hired in Sudan ISD.

Sudan ISD Guidelines

Campus principals will inform the Superintendent with the recommendation of extending a probationary contract. The school board will be informed when reviewing all contracts of professional personnel.

7.) Site-Based Decision Making

(BQ Legal/Local, BOA Legal/Local) (Texas Education Code 11.251 & 11.252)

Currently

Sudan ISD seeks exemption from the site-based decision-making process and the convening of the school health advisory committee and the many accompanying requirements falling under the governance of those two bodies. The statutory requirements as set forth in the Texas Education Code in Chapter 11 are burdensome, time consuming, and ultimately cause a misdirection of resources from the primary focus of schools: the education of students. Stakeholders will continue to be involved in the process, but one that meets the needs of the District, school, and community as opposed to the board brush of statutory requirements leveled down from a one size fits all approach as detailed in the code.

Sudan ISD Proposed

In place of the SBDM and the SHAC, a Superintendent's Advisory Council (SAC) will be established, meet, review, analyze, and respond to both qualitative and quantitative data regarding the district's success and most importantly, student's success. This council will convene at least two times per year and generate the general direction of district resources and efforts. This exemption will consolidate the number of meetings and the number of committees required by law and will better serve this community. This consolidation will yield greater opportunity for one council to address a multiple of needs as opposed to having one meeting after another throughout the year.

Sudan ISD Guidelines

This council will convene at least two times per year and generate the general direction of district resources and efforts.
